1. We refer to the above matter and especially to our letter of 15 May 2003 under cover of which we forwarded to yourselves a bundle of documents for your clients' attention.
2. As pointed out in that letter we indicated that our client was not willing to discuss this matter through the media. We invited any enquiry or comment to be forwarded to these offices for our clients' attention. It is with regret that we therefore find that your client has chosen not to approach us but rather to address this issue through sensational allegations in the media and, moreover, to do so at a time when our client was overseas.
3. We once again state that our client is not willing to deal with the matter in a similar manner. Your client's representative has alleged in the media that our client has not provided it with certain documentation. In an endeavour to address your clients' concerns we hereby invite your client to indicate based upon the agreement between our respective counsel what documents it believes it is still owed. Our client undertakes to follow up and provide any relevant document not already released, if this be the case.
4. Given the nature of this matter as well as your clients threatened legal action against our client as mentioned in the media and conveyed to a senior staff member of our client we must reiterate our previous request that your client refrain from communicating directly with our client or anyone in our client's employ.
